oper/Case Manager. Ms. Boston served on as an elected member of the Prince George's County, Board of Education from 2010-2018 where she served as a Board Member and Vice Chair for 6 years.

Ms. Boston is a distinguished community and civic leader. Her dedication and advocacy have led to improved support services for students with special needs. During her tenure, she successfully worked to increase resources for schools and established programs and policies to support parent engagement and increase per-pupil spending. Ms. Boston fought for the re-establishment of full day Pre-K, and middle school sports. She help establish the Spanish Immersion Programs; established partnership with "World Vision" to provide needed supplies and funding for Title 1 schools and worked with the leadership of the "Coalition for Public Safety Training in Schools" to provide opportunities for the Fire and EMS Cadets program; she secured funding for school construction projects at Central High School, Friendly High School, Thomas C. Pullen CPA, and Walker Mill MS; she helped to create real jobs for graduating students in career training programs and Construction Apprenticeship Programs; and helped to secure millions of dollars for our teachers and staff. She co-chaired a taskforce to eliminate wasteful spending within PGCPS; she established and coordinated the Board's largest annual district-wide "College and Career Readiness Summit"; conducted district-wide "Common Core Parent Workshops" and held numerous community workshops in school district 6. She served on the "Maryland Association Board of Education" conference planning committee and awards committee. She served on the Board of Education's Community Engagement Committee, Policy and Procedures Committee, CEO and Board Evaluation Committee, and Chaired the Governance Committee and Finance and Budget Committee.

Ms. Boston developed a useful understanding of the needs of students, parents, teachers, employees, and the community – one that only comes from the kind of hands-on involvement she has experienced. She became an advocate for parents, students, and teachers while serving as President of the PTA at Robert R.
